In the identified area, the current year population is 89,666. In 2010, the Census count in the area was 71,126. The rate of change since 2010 was 2.08% annually. The five-year projection for the population in the area is 97,681 representing a change of 1.73% annually from 2021 to 2026. Currently, the population is 47.8% male and 52.2% female.

Median Age

The median age in this area is 37.7, compared to U.S. median age of 38.5.

Households by Income

Current median household income is \$71,868 in the area, compared to \$64,730 for all U.S. households. Median household income is projected to be \$78,397 in five years, compared to \$72,932 for all U.S. households

Current average household income is \$88,827 in this area, compared to \$90,054 for all U.S. households. Average household income is projected to be \$99,106 in five years, compared to \$103,679 for all U.S. households

Current per capita income is \$31,036 in the area, compared to the U.S. per capita income of \$34,136. The per capita income is projected to be \$34,577 in five years, compared to \$39,378 for all U.S. households

Currently, 67.6% of the 33,400 housing units in the area are owner occupied; 26.0%, renter occupied; and 6.4% are vacant. Currently, in the U.S., 57.3% of the housing units in the area are owner occupied; 31.2% are renter occupied; and 11.5% are vacant. In 2010, there were 27,332 housing units in the area - 64.3% owner occupied, 26.9% renter occupied, and 8.8% vacant. The annual rate of change in housing units since 2010 is 9.32%. Median home value in the area is \$202,762, compared to a median home value of \$264,021 for the U.S. In five years, median value is projected to change by 2.68% annually to \$231,379.
